I\We agrees to grant to the Bost Group a legal mortgage of any land at any time held by me\us and as beneficial owner charges in the Bost Group's favour all property, assets and undertakings at any time held by me\us as security for the payments required to be made and performance by the Hirer of its obligations under the Terms and Conditions of Hire or any Sales Agreement. I\We acknowledge and agree that the Bost Group may lodge a caveat on title of any property held by me\us or register a charge in favour of the Bost Group in respect of any or all property, assets and undertakings of mine\ours, and the I\we shall not make any objection, requisition or claim in relation to any such caveat or charge and will sign all documents and offer all assistance necessary to give effect to this clause.
