## GENERAL TERMS & CONDITIONS

- All rates exclude GST and all rates are depot to depot unless agreed otherwise
- Depot to depot is defined as the travel and crane usage time from leaving a Surf City depot to returning to a Surf City depot
- Southeast Queensland and Northern NSW is defined as a site within 100km of Brisbane City GPO Box
- All above Cranage hire rates include a competent operator unless noted above as Dry Hire. Additional labour including Dogman, Riggers, Spotters, Supervisors, Labourers will be charged as Labour as above on hourly rates.
- Rates quoted are for normal working hours Monday to Friday (7am – 3.00pm) QLD time.
- Penalty rates apply for Overtime outside normal working hours, including weekends & Public Holidays and apply to all Surf City provided labour.
- A four (4) hour minimum hire on labour applies on weekends.
- Night shift incurs an eight (8) hour minimum hire on labour, (4) hour minimum on crane. Price on request.
- Public Holidays incur an additional rate per hour / per man, eight (8) hour minimum hire on labour only.
- SCC reserves the right to charge a cancellation fee if cranes are cancelled within 2 hours of start time.
- When a crane is left on site, Crew Travel including the operator is charged depot to depot at standard Dogman rate for all engaged staff for that day.
- Where a larger Class crane not requiring counterweights is provided to a site at the discretion of SCC, the cranage rate will revert to the larger crane's wet hire rate and counterweight charges will not be applied
- Cranage rates are charged on Class
- Where a larger Class crane is provided to site and is engaged outside of the scope of the original lift plan, Surf City Cranes reserves the right to charge the wet hire rate of the larger crane
- All of our staff are inducted into the systems and procedures developed by Surf City Cranes under our various ISO accreditations and accordingly it is our recommendation that all labour supporting the supply of our cranes is supplied by Surf City Cranes.
- Special penalty rates apply for after hour call outs extending beyond 8pm and where operator 10hr breaks and 8-hour minimum pay rates are incurred. Special Site Allowances and induction costs are not included in the above rates are to be paid by the hirer unless otherwise agreed.
- Ancillary Equipment, Block cages, concrete kibbles, man boxes, sully/man box, spreader beams, boat slings will incur a minimum pickup / delivery fee. On-going hire attracts a weekly hire charge advised at time of hire.
- If rates quoted are project specific, rates sheet must be signed or it reverts back to standard rates.
- Any marketing material in which Surf City Cranes (SCC) and subsidiary companies are featured or used, a copy is to be provided to the SCC for marketing purposes.
- SCC is to be provided with a list of sub contractors on site and is permitted first right to offer cranes/ancillary equipment to these contractors. The principal contractor will assist where possible.
- Sub contractor crane hire rates may increase without notice and charges may vary on cross hire. These are valid at time of printing. Sub contractors charge through Surf City Cranes.
- Surf City Cranes will not accept any responsibility for onsite damages to site or services as a result of poor access and/or conditions.
- Rates are based on Surf City Cranes fleet only and are not inclusive of tolls, subcontracted traffic control (if necessary) or other external costs which will be charged to the hirer additionally.
- Fuel excise will also be charged.
- Payments are COD unless you are an approved Account. EOM thirty (30) days may apply for approved customers.
